Toby Rickman graduated from Washington State University in 1983 with a bachelor's degree in civil engineering. That same year Toby went to work for the Washington State Department of Transportation, working in various positions across the state. In 1989, Toby received a master's degree in civil engineering from the University of Washington. During his 21 years with WSDOT, Toby worked in many areas from planning and programming to design and construction, and maintenance and operations. Toby has been recognized by APWA as a National Top 10 Public Works Leader in 2022.
