**Re: Approval of CEUs for 2016 Oregon Operators Training**

Dear Members of the OESAC CEU Committee:

The Umpqua Basin Operators Section (UBOS) of Pacific Northwest Clean Water Association (PNCWA) Umpqua Community College (UCC) and American Water Works Association (AWWA) are hosting the 2020 Oregon Operators Training scheduled for three days on August 11 – 12. We have also included Cross Connection Specialist Recertification as a pre-event session on Monday August 10<sup>th</sup>.

UBOS and UCC have been working with section representatives from the Oregon Region PNCWA and AWWA to organize the training. COVID-19 and restrictions on meeting size impacted the venue for this year's event. Historically the event has offered continuing education (CEUs) for Water and Wastewater Operators with attendance of approximately 200 students.

This year the event will be virtual with videos of the instruction livestreamed through Zoom. Each session will be proctored.

UCC and UBOS are excited to submit the schedule of courses and instructor background information forms for the 2020 program and to request OESAC CEU approval for the courses. CEUs will be offered for:

Monday, August 10th

Cross Connection Specialist Recertification (0.6 CEUs proposed)

Tuesday-Thursday, August 11th, August 12th, August 13th

Drinking Water Distribution and Treatment System Operators (2.1 CEUs proposed)

Wastewater Collection and Treatment System Operators (2.1 CEUs proposed)

Onsite Septic Installers and Maintenance Providers (1.8 CEUs proposed)

Many of the operators have multiple certifications, and have an opportunity at the short school to receive CEUs for more than one certification. A single course may provide CEUs towards more than one certification. On the attached program we have identified the requested categories for CEUs with the following CEU key: W = Water, WW = Wastewater, OS = Onsite, CCS = Cross Connection Specialist.

A number has been assigned for each course on the attached program to cross reference with the instructor forms.

This is a very important educational conference for local operators and operators throughout Oregon.
