Public Agency Defensive Driving

 - Stopping distance, reaction time, scanning ahead, changing lanes, blind spots.
 - Passing safely
 - Using cruise control and when not to use it
 - Avoiding a head-on crash
 - Work zones
 - Distracted driving

 - Pedestrians, including at crosswalks and in school zones
 - Bicycles, motorcycles, and recreational vehicles
 - Trucks, buses, and emergency vehicles
 - Aggressive drivers

 - Weather: risks and keys to safety, special braking, preparation, hydroplaning
 - Driving under the influence of intoxicants
