In-person/Virtual/Hybrid

PNCWA will be hosting a hybrid conference in September 2021. PNCWA 2021 will include an in-person conference in Boise, Idaho along with continued virtual conference engagement options both the week of the conference, and the weeks following, for those who do not wish to travel. We look forward to living out our conference theme- Ripples of Change: Creating Our Future.

PNCWA is offering a virtual component for attendees who will not be able to join us onsite. This virtual component will include 3 live streams on Monday, September 13th through Wednesday, September 15th of the in-person conference where virtual attendees will be able to watch the sessions at the same time as our in-person attendees via the conference platform, Pheedloop. We will host a variety of presentation topics throughout the live streams.

Once the in-person event is complete, PNCWA will host the recorded live streamed sessions for viewing in the conference platform until December 31, 2021.

PNCWA will track attendance of the livestream sessions via the conference platform. We will review attendance by reviewing how long attendees watched each presentation for, requiring attendees to answer a pop up question throughout the session, periodically monitoring attendee activity, and encouraging attendee participation and to ask course related questions throughout the session.
