Oregon - 5-hour Utility Management for Class 1 and Class 2 Waterworks Operators

Course Description: This five-hour class satisfies 5 hours of the 20 hours of continuing education needed to renew a waterworks operator's license in Oregon. The class contains two instructional modules: The first module is on "waterworks management" and includes the following:

- What Makes a Good Manager;
- How to More Effectively Manage Your Waterworks Operation;
- Management Theories a chance to see how managerial philosophies and strategies have evolved over the years and what has been learned from this history that can inform how we effectively manage today; and
- Risk Management a specific area within management that is especially vital for waterworks operations.

The second module covers "Security and safety procedures" and utilizes recommendations by OSHA, NIOSH, the EPA, the AWWA, and other industry organizations to address:

- The risks to which Water Treatment Operators are exposed in a typical work environment;
- Ways to mitigate or avoid these risks
- Reporting requirements;
- Who's responsible for workplace safety;
- First aid and access to care for more serious injuries; and
- Common-sense recommendations for how to work more safely and help to make water/wastewater (w/ww) treatment facilities as illness and injury-free as possible.

Learning Objectives:

By the end of this course students will be able to:

- Apply enlightened and effective management techniques;
- Prepare and Implement a risk management plan;
- Identify risks at w/ww treatment facilities;
- Respond to injuries or illnesses appropriately; and
- Foster a culture of safety that trains staff how to identify and mitigate hazards.

Assessment:

Student's fulfillment of the learning objectives is verified through 13 in-text questions, with one question following each video or topic-based lesson. Students must answer each in-text question correctly to proceed to the next video or lesson in the class.
